The Master Plan was presented to the public at a meeting in the North Allegheny High School on November 9, 1965, and was adopted by the Board of Commissioners at their regular meeting on Nov. 22, 1965. This will be implemented by a revised planning Ordinance, revised zoning Ordinance, and other actions by the Board. Public hearings will be held on the Ordinances after the final drafting. Over 5,000 tabloids of the Master Plan were mailed out to residents of the Township. Copies of the Master Plan, in attractive binder and containing many maps and photographs, are offered for sale at the Township Building for \$1.00 each.

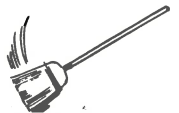

1965 Road Department

Road Department Superintendent Donald Falkner operates with 12 men as regular personnel and extras as needed for snow removal in incimate weather and road re-surfacing in good weather. The costs of snow and ice removal were as follows:

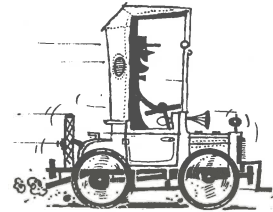
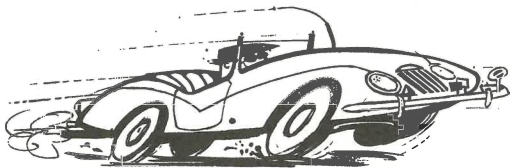

One new truck was added at a cost of \$3,300.23 (less \$911.00 trade in for the old) or \$2,389.23. Total cost of Miscellaneous tasks such as repair of traffic signs, replacement of traffic lights, painting, brushing, guard rail repairs, dead animal removal, etc. amounted to 13,414 hours for \$30,895.38. Road Department tools and equipment were purchased for \$1,200. Other Road Department costs were:

Patching Township roads	2,499 hours for \$11,994.41 (time and materials)
Drainage of Roads and Ditches	4,538 hours for 12,252.28
Resurfacing and sealcoating	2,696 hours for 38,294.52

In 1965 16 streets were added to the Township list totaling 2.09 miles, and bringing the Township level up to 59.65 miles.

The members of the Road Committee of the Board of Commissioners consist of Wilbert F. Krueger, Chairman, John J. Schuler, John J. Nutter, and Oliver T. Leggett. The above members, along with other members of the Board, devote much time in viewing work developments which are built in the Township, and resolving road problems.

247 of the Building Permits were issued for new homes for an estimated value, less land costs, of \$4,997,950.00 making the average home value of \$20,234.00, for construction costs only. This compares with the average home cost in 1964 of \$19,813.00. There were 64 permits issued for additions and alterations in 1965 as compared with 54 in 1964. Private garages and carports amounting to \$24,700.00 account for 11 permits. Additional classrooms added to the North Allegheny School District at Peebles Road was commenced at a construction cost of \$315,000. St. Alexis Church on Old Perry Hwy. added a Convent to their grounds at a cost of \$111,000. A branch of the Mellon National Bank was built on Peebles road for a cost of \$100,000, and Kaufmann's, our largest new structure, was started in May at a cost of \$2,500,000. These items, plus the cost of the additions and alterations of \$184,550 bring the total valuation of structures to \$9,132,895.00.

In addition to building inspection, inside sewer lines and plumbing inspection was carried on by the Building Inspector, and outside sewers and laterals were inspected by the Sanitary Director, which included the following:

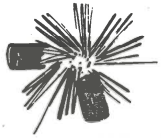

1965 Receipts and Expenditures



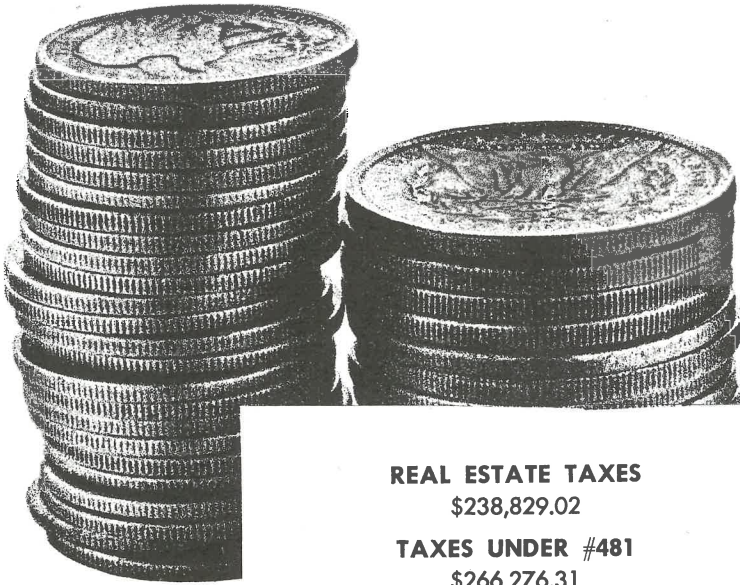

Schools and Instructions

Commissioner Oliver T. Leggett attended a course on "Introduction to Modern Municipal Government" at the Institute of Local Government, University of Pittsburgh.

In 1965 Chief of Police Harry Wylie spent two days at the Pennsylvania State Police Academy at Hershey, Pa. studying Racial Control and Child Behavior, and along with Lt. Wm. Blakley, attended a seminar at the University of Pittsburgh on Police Administration. They also attended the Mayor's Highway Safety Council meeting in Pittsburgh. Officer Charles P. Toth and Mr. Wylie attended a seminar at the University of Pittsburgh on Child Behavior, and Lt. Blakley, Lt. Geisler, and Chief Wylie attended a seminar on the use and control of the new State Accident Report form, which is to be submitted to the State of Pennsylvania on each accident.

Chief Wylie attended the F.B.I. School which was held at the Shaler Township Municipal Building one night a week for four weeks in regards to the detection and control of Moral offenders. Officer LeDonne, Officer Osborne and Officer Richard Pezich are attending a twenty-one week course on Advanced Police Procedures sponsored by the Pennsylvania Bureau of Public Instruction. This school is being held at North Allegheny High School with the Instructor, Pat Nelson, furnished by the Bureau of Public Instruction.

Mr. Karl Sattler, Mr. R. M. Mamula, and Mr. Harry Windhorst attended a six-week course at the University of Pittsburgh on "Modern Building Inspection," sponsored by the Institute of Local Government and the Building Officials Conference of the Upper Ohio Valley. In the Spring of 1966 they also attended a six-week course in Zoning Law and Administration sponsored by the Institute.

1965 Police Department

The McCandless Township Police Department consists of the Chief, two Lieutenants, nine Patrolmen, four Desk Clerks, twelve uniformed Auxiliary Police and nine School Guards. The Department lost one Lieutenant due to the death of Lt. Roy Yingling on March 20, 1965. This vacancy has not yet been filled, but Richard Pezich was appointed to the position of Patrolman on October 1, 1965.

The dog catcher spends a minimum of three days a week or a minimum of four hours a day, patrolling the Township. He also comes into the Township on emergency calls and at various times during the week to pick up dogs placed in the kennel at the Township Building by Township residents.

The equipment consists of two 1965 Chevrolet Station Wagons—converted into ambulances. Each ambulance is equipped with a stretcher, an oxygen bottle and a set of air splints. The Department has one machine gun, two 12 gauge shot guns, two mechanical dog snares, and one camera. The Police Department also purchased twelve riot helmets and twelve riot sticks along with one tear gas gun, cartridges and grenades. The fully equipped ambulances are available to all residents of the Township for emergencies.

1965 Zoning Board of Adjustment

The Zoning Board of Adjustment consisted of the following members: Mr. William Halboth, Chairman, Mr. David Cooper, Vice Chairman, and Mr. William Appleton, the third Board member. Mr. Karl Sattler, Wage Tax Collector, and Mr. R. Mamula, Interim Building Inspector, served as Secretary to the Board.

The Board met each month on the 4th Friday for its regular meeting. In addition to these 12 stated meetings, there were 3 special meetings called during the year. Of the 51 cases heard during the year, variances or special exceptions were granted in 48 instances, 3 were turned down and 2 were postponed.

In order to clarify the duties of the Zoning Board of Adjustment, the following information is repeated from the By-Laws and the Zoning Ordinance. Anyone aggrieved by the refusal of the Building Inspector to issue a Building Permit may, within 20 days, enter an appeal for a hearing before the Zoning Board of Adjustment. The Building Inspector, in his additional role as Secretary for the Board, takes the appeal and prepares the papers for the hearing. The Zoning Board members on the 3rd Friday of each month pick up 5 signs of notification of the hearing, one of which is posted in the Township Office and the other 4 on the property involved. This enables the Board members to view the property and study the problem connected with the appeal prior to the meeting for the hearing.

The Zoning Ordinance, Art. XII, Sec. 1203, Part II states as follows: "Any person, firm, partnership or corporation, jointly or severally aggrieved by the decision of the Board of Adjustment, or any Taxpayer, or any officer of the Township, may, within thirty (30) days after the filing of the decision in the office of the Board, appeal to the Court of Common Pleas of Allegheny County, Pennsylvania."

If a variance or special exception is granted, a Building Permit will be issued if applied for within a period of 6 months. If it is not applied for in this time, a new hearing will be required.

1965 Activities

The financial condition of the Township ending the year of 1965 is good with approximately \$11,000.00 surplus. 363 Building Permits were issued with a value of \$9,132,845.00, less land costs. The six new residential developments in the Township were as follows:

Greybrooke Plan #2	60 Lots
Wyndermere Plan #9	8 Lots
Covington Place	52 Lots
Timber Ridge Plan	70 Lots
Collington Plan	13 Lots
Prescott Terrace #2	49 Lots

Of the above Plans, the Collington Plan consists entirely of Duplex Dwellings at a construction cost of \$416,000.00. Along with this, three other duplex dwellings in the Township made a total cost of \$484,000.00. For 16 two-family residences.

The Zoning changes made in 1965 were:

- Shemaka property, Route 19, R-2 to Commercial
- Warr property, Route 19 and Birch Ave., R-2 to Commercial
- Beckman-Swenson, Pine Creek and Rinaman, R-2 to Professional Office District
- Brown & Vaughn, Sloop Road, R-2 to R-4 Multiple Dwelling

The Civil Service Commission held an examination, and established an eligibility list from which one Police Officer was selected.

Three fire departments are supported by McCandless Township. One mill of taxes is allotted for fire protection, \$9,810.00 to each department, making a total of \$29,430.00. Balance of one mill goes for fire hydrant rental. The Highland Fire Company is now equipped with a modern ladder truck.

Over two miles of new permanent type streets were constructed by developers and accepted as Township streets. Louisville Drive and North Florence Road were constructed by the Township, over four and one-half miles were seal-coated and one-half mile was resurfaced with ID-2 hot mix asphalt. Other streets were patched and given normal maintenance. Extensive improvement to Peebles Road was made by Kaufmann's with the exception of a slag base which was furnished by the State.

An extensive storm drainage system was constructed in Windsor Place for a cost of \$78,848.51. Other storm drainage was constructed by the Road Department in the Ingomar North Plan and other minor structures and extensive storm drainage maintenance was conducted.

The Institute of Local Government

As in the past, McCandless Township participated in the Institute of Local Government. Last year the Institute, in cooperation with the Building Officials Conference of the Upper Ohio Valley, sponsored a field trip to the Admiral Homes Company in West Newton, Pa. Along with the McCandless Township Building Inspector, fifty-four other building officials from municipalities in the tri-state area toured this plant and observed the complete assembling, fabrication, packaging and shipping of mass production homes to many parts of the country.

The Institute has been serving local government since 1944. It has been conducting short courses and conferences, providing headquarters service for official associations, and serves as a study center and clearing-house of information for municipal officials. It has been conducting conferences on such subjects as zoning, subdivision control, refuse disposal, and planning. Among the courses offered periodically are those for municipal secretaries, planning commissioners, assessors, borough and township officers, civil service commissioners, and newly-elected officials.

Courses and conferences are open to any public official, although, on occasion, special conditions of experience or prior course work must be met. Officials completing requirements are given an appropriate Certificate of Recognition. In a single year, several hundred such certificates have been awarded.

Closely allied to the courses and conferences is *The Local Government Newsletter*. Published monthly, (except July and August) it has a circulation of over 3500 and contains editorial material, articles on timely municipal developments, legal reviews, library notes, news items, and announcements of personal interest. *The Newsletter* is distributed free as a service of the Institute. Its columns are always open to officials who wish to discuss particular problems or ideas of municipal concern.

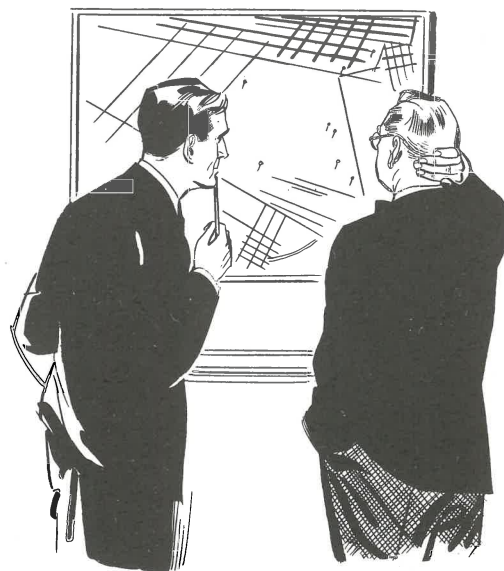
