# 1966 Zoning Board of Adjustment

The authority of the Zoning Board of Adjustment is in accordance with Article XIII, Section 1200 of Zoning Ordinance known as Ordinance No. 6 of McCandless Township and was ordained and enacted into law of the Township by the Board of Township Supervisors on November 7, 1947 and became effective on November 18, 1947.

According to the Zoning Ordinance and By-Laws, any person dissatisfied by the Building Inspector's refusal to issue a permit, may, within a period of 20 days, apply for an appeal for a hearing before the Zoning Board of Adjustment. One week prior to the meeting of the Board, four signs are posted at or near the site in question and one sign is posted in the Township bulletin board by the Secretary. This gives the Board an opportunity to view the area involved and to better evaluate all the facts concerned. If the Zoning Board confirms the Building Inspector's decision, the Zoning Ordinance, Article XII, Section 1203, Part II states, "Any person, firm, partnership or corporation, jointly or severally aggrieved by the decision of the Board of Adjustment, or any taxpayer, or any officer of the Township may, within thirty (30) days after the filing of the decision of the Board, appeal to the Court of Common Pleas of Allegheny County, Pennsylvania."

When an appeal is granted, a Building Permit may be issued providing that it is applied for within six months. If this is not applied for in this given time, a new application for a hearing is necessitated.

The following members comprised the Zoning Board of Adjustment: Mr. David Cooper, Chairman, Mr. William Appleton and Mr. Edmond O'Neill. Mr. Robert Mamula, Building Inspector, served as Secretary to the Board.

In addition to the 12 regularly scheduled meetings held on the 4th Friday of each month, the Board convened four special meetings in 1966. 54 appeals were presented of which 38 were granted requested variances, 14 were denied, and two were withdrawn.

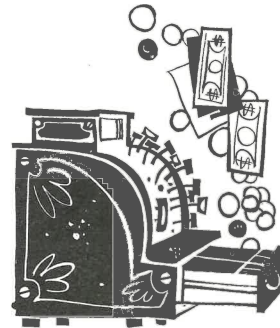
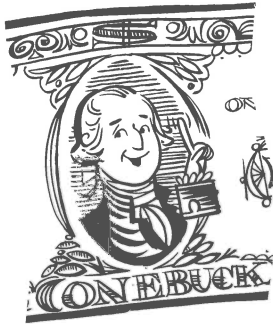

# 1966 McCandless Township Police Report

The McCandless Township Police Department again suffered the loss of a police officer in 1966, this time through a resignation. Officer Novak resigned to take the position of Chief of Police in Franklin Park Borough. This reduces our Department to chief, two lieutenants, eight patrolmen, four desk clerks, twelve uniformed auxiliary police, and nine school guards.

The dog catcher spends three days a week or a minimum of four hours a day patrolling the Township. He also comes into the Township on emergency calls and various times during the week to pick up dogs placed in the coop at the Township Building. We also have had him in numerous times during which the police officers assisted him in various sections of the Township in an effort to round up excessive strays.

The Department's equipment consists of two 1966 Chevrolet Station Wagons—converted into ambulances. Each ambulance is fully equipped with a stretcher, an oxygen bottle and a set of air splints. Other equipment includes a machine gun, 2 mechanical dog snares and one camera. A tranquilizer gun was purchased to assist in animal control.

A new burglar alarm system was installed in the Municipal Building which should alleviate the unsightly equipment that had existed in the past. A new mobile radio was purchased and installed in the Chief's car to enable him to keep in constant contact with the office. The following table gives a report of the operating costs of the vehicles in 1966, in comparison with costs for 1965:

Officer Ralph LeDonne and Officer James Osborne attended the Municipal Police School at the State Police Academy, Hershey, Pa. This was an eight week course in which Officer LeDonne finished second highest in the graduating class of 100 Municipal Police Officers.

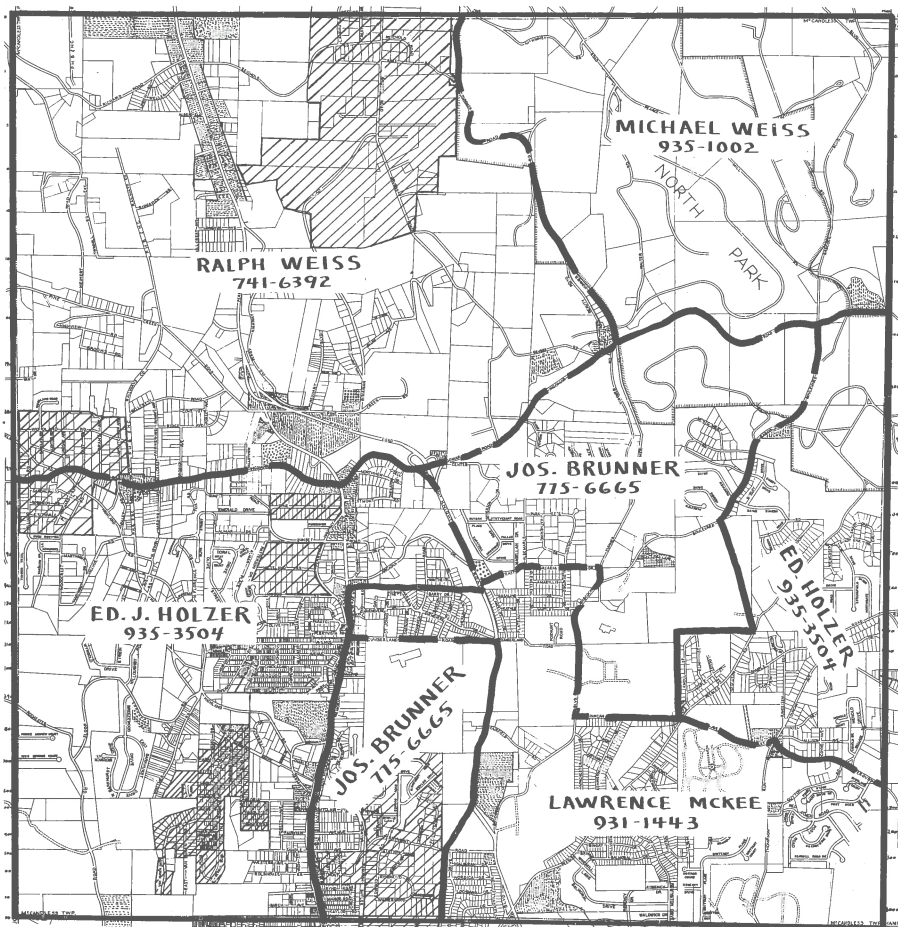

# Rules and Regulations for Refuse Collection

There are five garbage and refuse collectors operating in the Township under an agreement with the Township wherein each collector has a designated area assigned for his exclusive operation.

Garbage is collected once each week and the charge for this service beginning July 1st, 1967 will be six (\$6.00) dollars per quarter for one container not to exceed twenty-five gallons in capacity, and an extra charge of twenty-five (25¢) cents for each additional container not to exceed twenty-five gallons in capacity for each time such container is emptied at such times as any individual customer may request picking up of an additional container or containers.

The individual collectors collect this charge from each individual property owner, and there are five clean-up campaigns of all properties serviced by the collectors during each year and the individual property owners are notified by postcard as to the dates of these clean-up campaigns, with this clean-up campaign being a part of the service rendered for the six dollar per quarter charge. At the time specified all rubbish must be placed at the curb in front of the property serviced by the collector, and all rubbish and trash with the exception of bricks, stones, earth or building material will be hauled away but trees or tree limbs shall only be taken when cut in lengths not over two feet and bundled or placed in containers.

The term 'garbage' includes all table and kitchen offal and waste including cans or containers, broken dishes, glass and china-ware, together with any and all paper or paper cartons in which such garbage may be wrapped.

The term 'rubbish' includes newspapers, paper cartons, magazines, old paint cans and other articles used about the household and shall include grass, weeds, trees and brush provided trees and brush shall be cut into lengths not over two feet and placed in containers. The term 'rubbish' does not include bricks, stones, earth or any building material.

# 1966 Inspection Department

In 1966, housing became the prime casualty of tight money. The booming corporate demand for funds, coupled with the anti-inflationary policies of the Federal Reserve System cut into the supply of mortgage funds and, in turn, depressed housing starts to a level not seen in six years. But this is history and our purpose is to look to the future.

We see brighter days ahead for the housing industry, beginning with the second half of 1967. Federal efforts to pump money into housing will provide some stimulus but more important will be the emergence of natural market forces.

Of the **296** Building Permits issued in 1966, **194** were for new homes as compared to **247** for last year. These new homes were built for an estimated value, less lot prices, of **\$4,411,700.00**, making the average cost of a new home **\$22,745.00**. This compares with the average home cost of \$20,234.00 for 1965.

102 permits were issued for alterations and additions for estimated construction costs of **\$1,363,722.00**. Included in this figure were: **\$500,000** for the La Roche College Library; **\$300,000** for additions to the Northmont U. P. Church; **\$165,000** for a new club for the North Park Sportsmen's Club; **\$158,000** for a dormitory at the Divine Providence; and **\$135,000** for additional offices for the Penn-Perry Roofing Company.

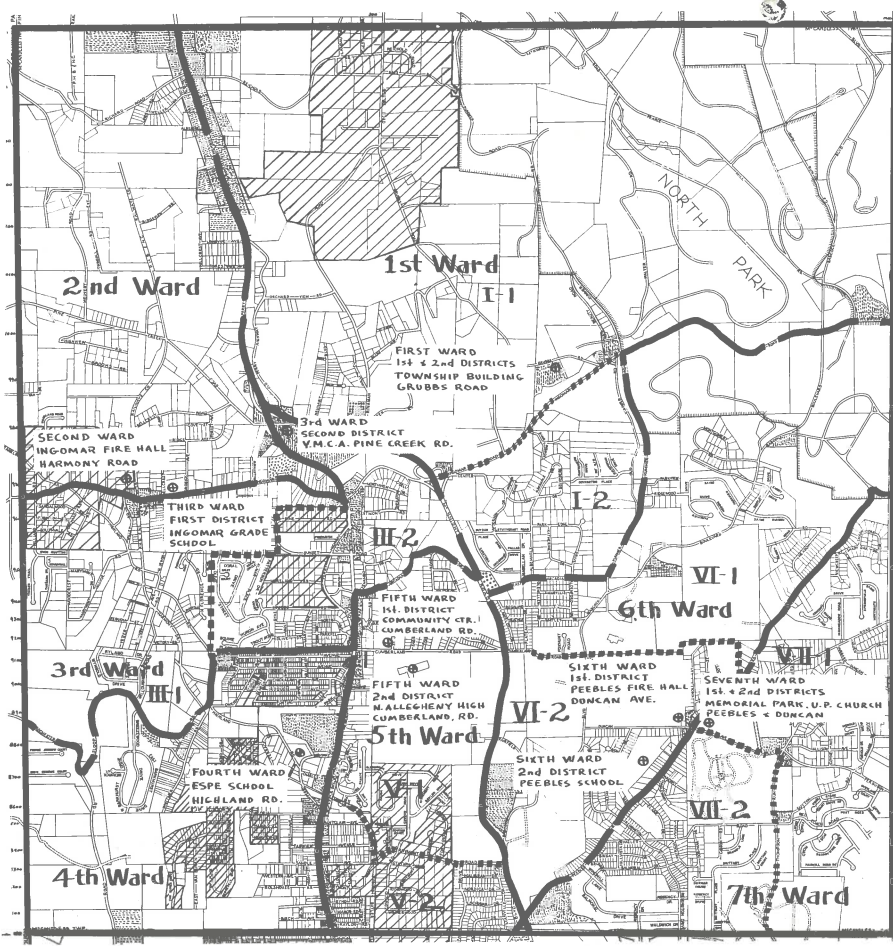

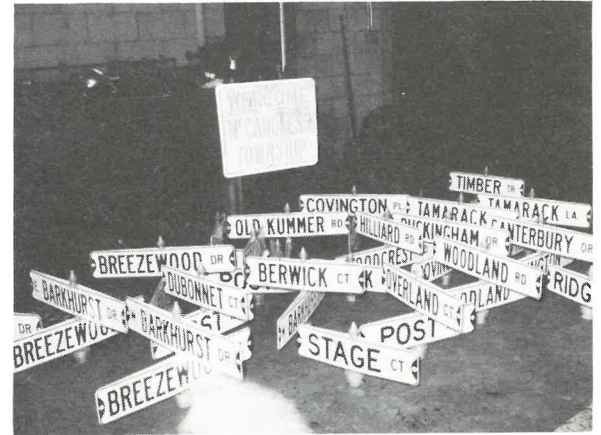

# 1966 McCandless Township Sanitary Authority

The McCandless Township Sanitary Authority, under the Municipal Authorities Act of May 2, 1945, P. L. 382, was ordained and enacted into a law of McCandless Township on December 14, 1955. Mr. Harry Windhorst, Superintendent, operates 8 Disposal Plants and 10 Pump Stations with a regular crew of 6 men and 6 extra men. Mr. Jos. W. Rodgers, Director, made 220 house sewer line inspections which were as follows; A & B Plant, 65; Lowries Run, 116; Longvue, 33; Crestwood and Montgomery, 4; and Briarwood, 2.

Lyda Schwer, Billing Department, reported the total number of accounts in all Sewer Systems as of December 31, 1966, as follows:

## HISTORY

The first McCandless Township Annual Report, six pages in size, was presented in 1954. From the 1950 U. S. Census the population was 6,488 compared with the 1965 U. S. Census of 17,560. The assessed valuation for 1954 was \$18,054,000 compared to the 1966 valuation of \$49,927,448. There were 40.59 miles of roads in the Township in 1954 as compared to 62.39 miles in 1966, despite the fact that we lost 3.4 miles to Ross Township in 1961.

## ANTICIPATED FOR THIS YEAR

Pave: Seminole, Pontiac, Seneca, Mohican, Huron, Oneida and Mohawk Avenues in the Highland Manor Plan. Widen and pave Old Route 19 from St. John's to St. Alexis. Pave Charles Street from Old Route 19 to Highland Road to New Route 19. Resurface Old Kummer Road. Pave other streets as needed. Install traffic signals at Babcock and Cumberland. Acquire right of way for extension of Cumberland Road from Babcock to Peebles Road at Sample Road. Participate in Library. Sanitary Authority will replace the disposal plant at Hazlett Road and construct sewers in the unsewered areas served by this plant. Expand the Police Department by adding five new Police Officers, and one police car and appointing one lieutenant.
